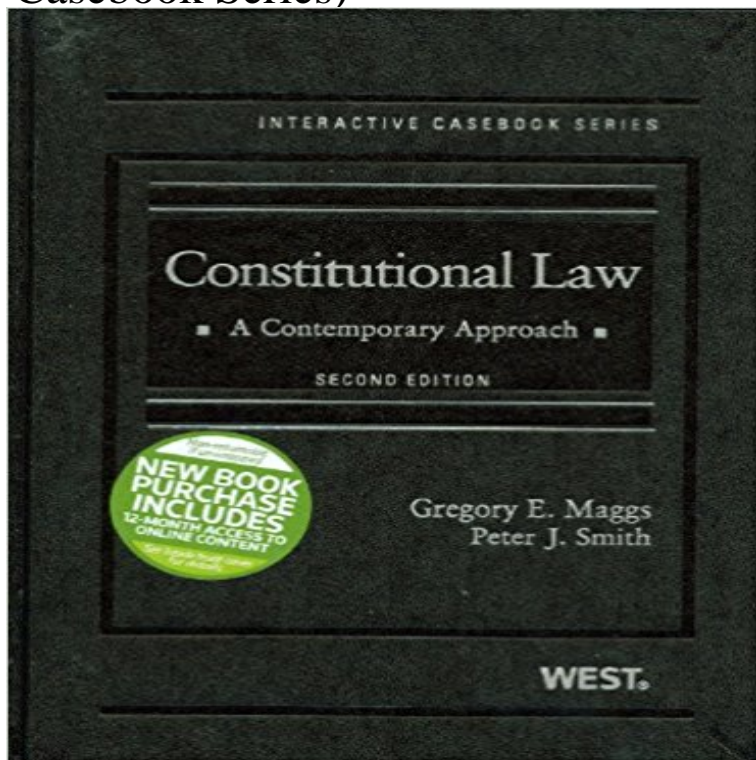


## Constitutional Law, A Contemporary Approach, 2d (The Interactive Casebook Series)
