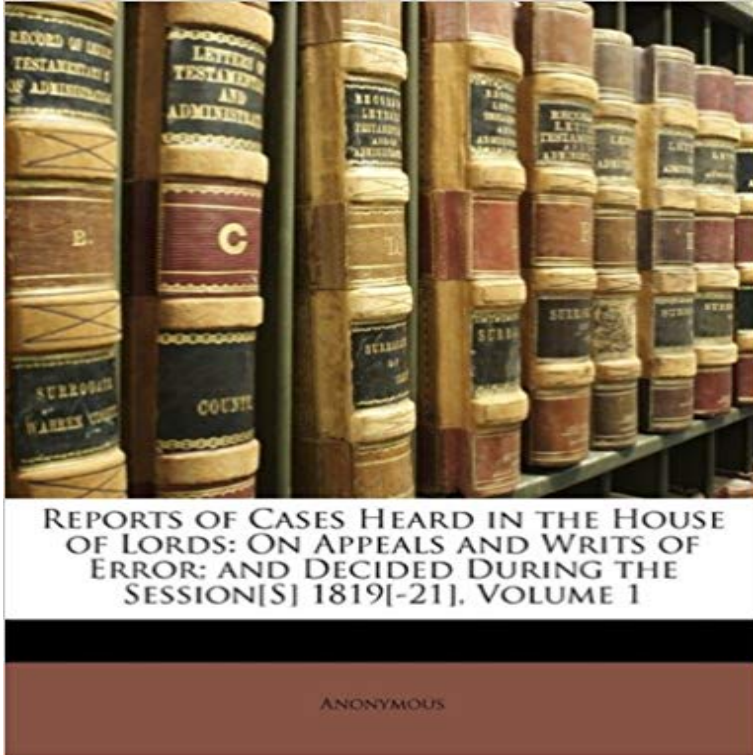


# Reports of Cases Heard in the House of Lords: On Appeals and Writs of Error; and Decided During the Session[S] 1819[-21], Volume 1
