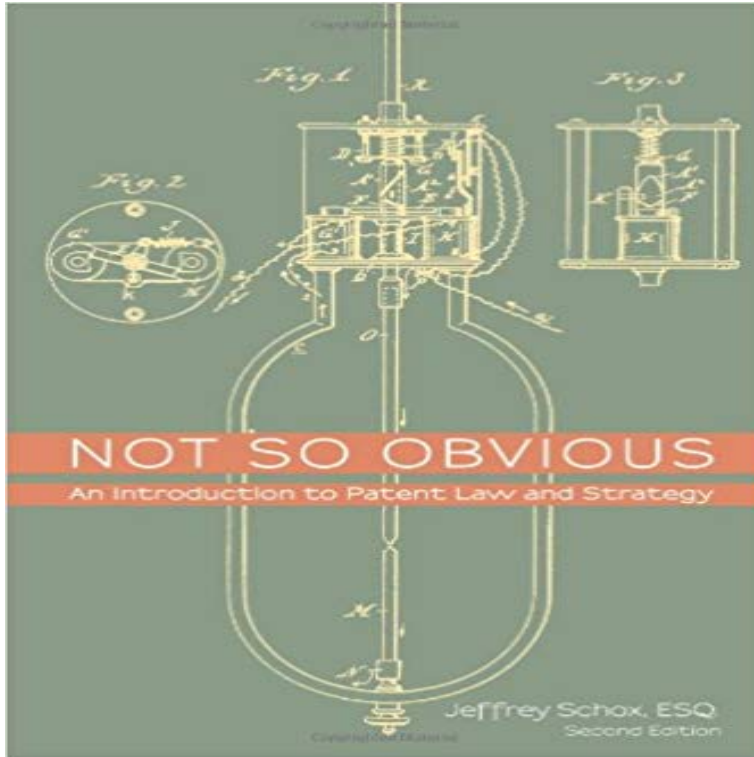


# Not So Obvious: An Introduction to Patent Law and Strategy - Second Edition
