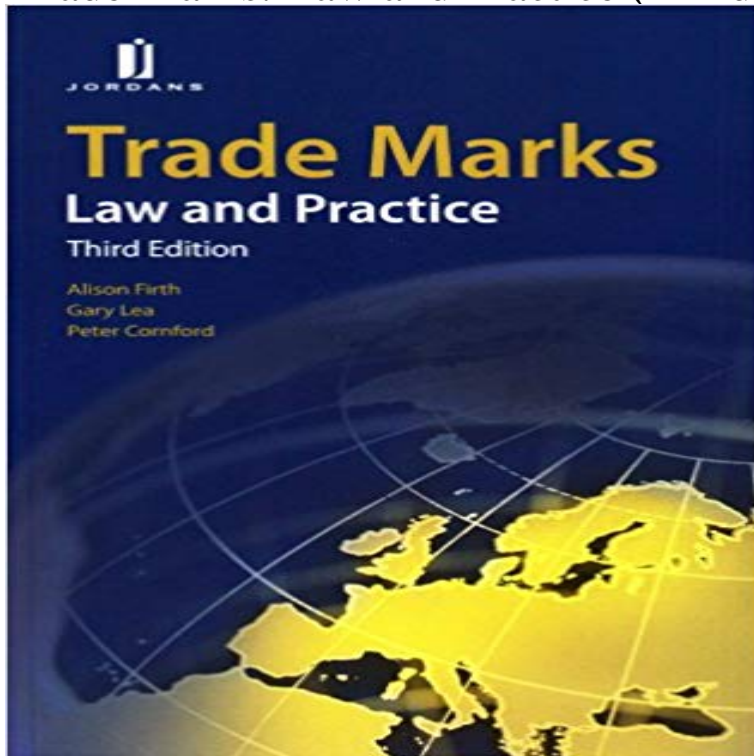


Trade Marks: Law and Practice (Third Edition)

The appendices include helpful consolidated versions of the Act and the Rules. It considers the commercial functions of trade marks and how to use them; how to protect trade marks; and the process of registration, licensing, and assignment.
